Anyone whom operates a golf cart must have a valid driver's license and must adhere to all posted club policies surrounding the operation of a power cart at the club.

The FMGC member and/or shared cart partner acknowledges personal liability to pay costs relating to the repair of damages they have caused to the course, power cart, and all other club facilities while in operation of a FMGC leased golf cart.

### Medical Flag - conduct & procedure policy

Fairview Mountain Golf Club prides itself on making our golf course as accessible as possible to all members of the club. We fully understand the challenges our terrain provides, especially with those who may have a medical disability. We have detailed below the special allowances for those whom fall under our "red medical flag" policy along with areas of no exception with regard to where and where not medical flag power carts can be driven.

#### Areas of special access

- Medical flags give members the ability to drive within the "white lines" in front of greens and
  the ability to pull off cart paths at tee boxes to gain the closest level access available when
  necessary. That being stated, carts are expected to be parked on level lies and cannot be driven
  on or up extreme slopes at any time. No exceptions. e.g. #2,#7,#8,#10,#11,#13,#15,#16 greens.
- 2. Areas of special access for extreme green slopes are listed below:
  - a. #7 back of green
  - b. # 8 back of green if needed
  - c. #10 medical flag users can access the green from behind using the paved maintenance road. Please drive with caution and always be aware of course maintenance staff at all times.
  - d. #11 access left of the green by using #17 cart path and pulling into pull off area. Be aware of people teeing off or driving from the #17 tee at all times.
  - e. #15 cart path only no exceptions
  - f. #16 cart path only. Easiest access is just off the existing cart path.
- 3. Golf carts should never be closer than 15 feet of a putting surface at any time. Please note we will be providing an educational seminar each year to clarify the proper usage of red flags.

This policy has been developed to protect our "medical flag" members, our club, and the structural integrity of our golf course. If anyone requires any further explanation of this policy or would like to be advised of areas on course, please contact the GM, Head Golf Professional, and/or golf shop team.
